

Step-by-Step Guide for Colombian Visitor Visa (V-visa) Application*

***The content and format of the visa application form may be changed by the Colombian authorities without prior notice. If you have any questions, please contact INFO@theicfp.org.**

Highlights of Visa Application for the ICFP 2025

- There are many countries and territories from which no visa is required to enter, remain, and leave Colombia for short-stay activities (including business, conferences, leisure, tourism, or cultural activities), provided that these activities do not generate payment for services, wages, or salaries in Colombia. Please find the list of countries and their specific visa requirements [HERE](#). This chart will also indicate the embassy to which you must send your electronic visa application if needed.
- For those needing a visa to attend ICFP 2025, **the visa review, processing, and issuance process is carried out entirely online** for a **VISITOR (V) EVENT PARTICIPATION/"V-visa"**.
- **No matter what your passport type regular or diplomatic, there are absolutely no visas issued on arrival.**
- We recommend that all needing a visa to enter Colombia **apply AT LEAST 60 DAYS PRIOR to their travel date**. ICFP 2025 attendees may apply for their visa up to 120 days in advance of the conference.
- If approved, the ICFP 2025 VISITOR (V) EVENT PARTICIPATION/"V-visa"-will be "valid during the dates of the conference November 1-6, (including the pre-conference dates) and beyond as a short-stay visa, usually up to 30 days. It is up to each consulate to determine the number of days each applicant will be able to stay in Colombia outside of the conference dates.

Steps to apply for a visa to enter Colombia if holding a valid passport from a country is NOT on the list of those exempt:

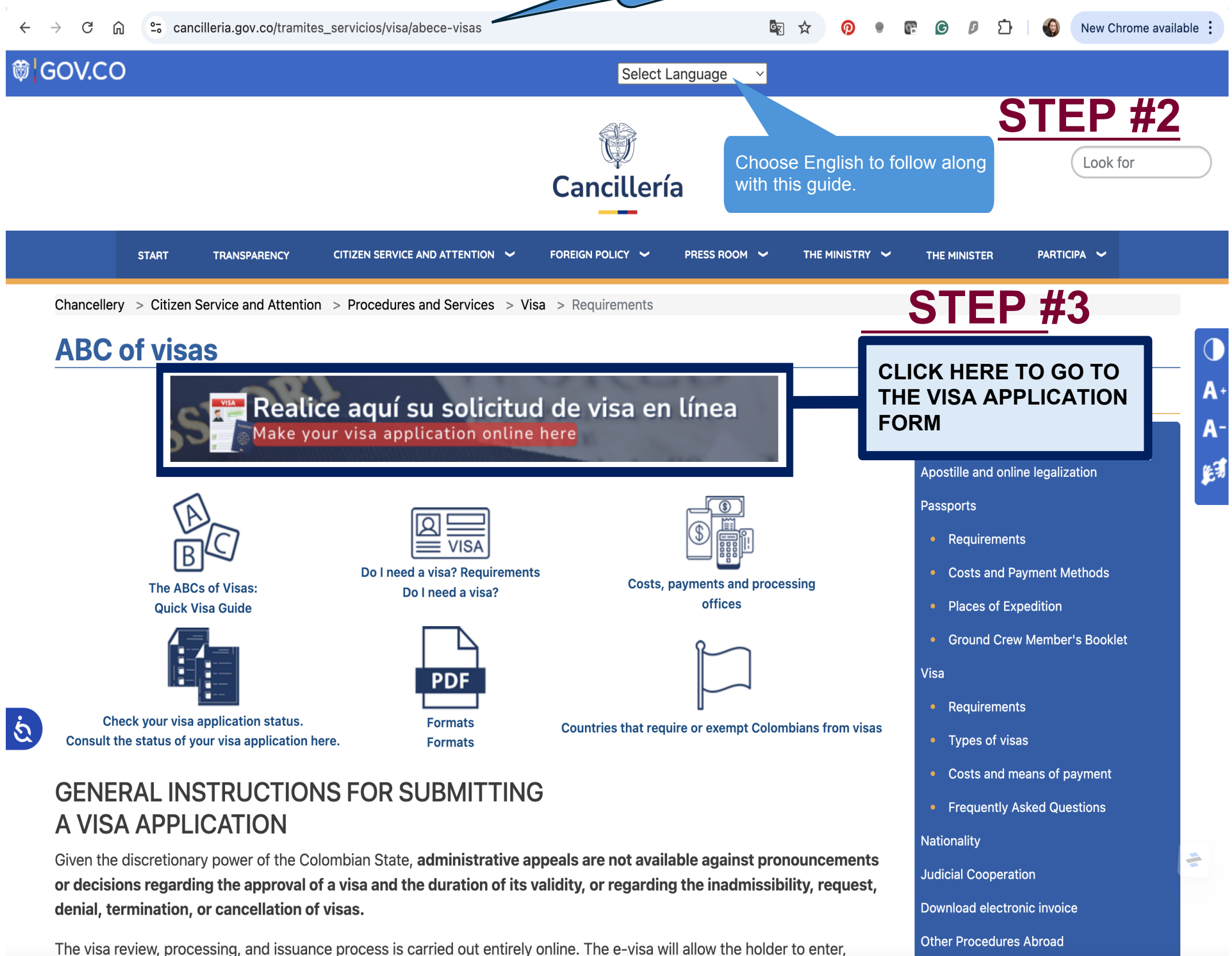
- Please be aware that for most visa applicants, TWO (2) PAYMENTS will be made in order to obtain your visa:
 1. for the visa application and
 2. to issue the visa once approved. Payments may be made **online** via Visa or MasterCard.
- You may process your online visa application form available on the official website of the Ministry of Foreign Affairs at: <https://tramitesmre.cancilleria.gov.co/tramites/enlinea/solicitarVisa.xhtml>, providing the requirements for each visa type and category. All ICFP 2025 attendees who need a visa should apply for a VISITOR (V) EVENT PARTICIPATION/"V-visa."
- When completing your application form, you must select the Colombian Consular Office **closest to your current country of residence**, or the country where you hold a temporary or permanent residence permit. You will find the name of the consulate to which you must apply online for your visa in the chart [HERE](#). (If you are in Colombia and have regular immigration status, when completing your visa application form, select "Bogotá Office" from the menu.)
- Before starting your online visa application process, **you must have at least 30 minutes to complete the application** and all materials ready, including:
 1. Recent color photo with a completely white background, without gradients or shadows, measuring 4 cm x 3 cm. You must be facing the camera and your head must be centered and complete. Both eyes must be open and your ears must be visible. There should be no glare in the photo. Do not allow hair or other accessories to cover your face. Do not use a photo from a previous visa (if you have one). The image format is JPG and must be no larger than 300 KB.
 2. Color photocopy of the biographical page of your passport, valid for at least 6 months.
 3. Letter of invitation or endorsement of the visa application signed by the representative of the entity responsible for the event.
 4. Attendees representing private entities or non-governmental organizations (NGOs) must attach a letter from the organization they represent at the event addressed to the Ministry of Foreign Affairs, fully explaining the event and including the dates and location where it will be held. This letter must also clearly include the full name of the participant, as well as their nationality and valid passport number, and state the type and scope of financial responsibility (coverage of expenses) for the participant during their stay in Colombia. A section must be included in which the organizer expressly states their responsibility for the participant's return to their place of residence or origin before the expiration of their visa. This letter must also include the relationship between the entity and the event organizer in Colombia.
 5. Delegates attending on behalf of a State must attach a Note Verbale addressed to the Ministry of Foreign Affairs of Colombia informing the appointment of the attendee as an official delegate of the foreign government during the event. (Attendees coming as delegates of a State or on behalf of a public entity are not required to comply with the last two points listed, below.)
 6. Certificate of existence of the entity supporting the application.
 7. Bank statements of the entity supporting the application. If you are supporting yourself to travel to the conference, these bank statements will be yours.

Please also note that once the visa office emails you with either further questions or they communicate that your visa application has been accepted, you must answer them or pay for your visa WITHIN 10 DAYS OR YOUR APPLICATION WILL BE WITHDRAWN AND YOU WILL HAVE TO START THE PROCESS OVER AGAIN.

- Read carefully and submit the requested information avoiding typing mistakes. Any inaccuracy or error concerning the information you submit to this electronic form, may lead to the application refusal, without any refund of the amounts paid.
- You must have at least 30 minutes to complete this online application.
- Before starting the online application process, you must have: a photo size 3x4cm, in color, with white background, recent, head-on, without accessories, clear visage, in JPG format with a maximum weight of 300 KB. Individual documents in PDF format, readable, in black and white presentation is advised. The maximum weight allowed for the total of documents attached to an application is 5MB.

- Please note that you should not attend to the Visa Office in Bogotá unless the Visa Authority requires personal presentation, notified to the registered email in the application form. Otherwise the visa application process will continue online.

- A visa does not guarantee access to Colombian territory, it only allows a foreigner to travel to a post of entry in Colombia and request permission to enter the country in accordance with the visa that has been issued.
- The list of countries or territories does not imply recognition of their name or legal status.

Privacy Notice and Authorization to handle personal data in the Integrated Citizen Processes System – SITAC – in the Ministry of Foreign Affairs

In order to comply with its obligations under law and contract, and to provide services as intended, the Ministry of Foreign Affairs and its Revolving Fund need to obtain certain information about you. This information includes your identity document, surname(s) and given name(s), demographic information, information on birth and residence; contact data and academic formation; it also includes biometric information (fingerprints, photo and signature) captured virtually or in person at the Ministry's offices to continue with the service, process or product you want. The data are also needed to reply to inquiries, complaints, claims, suggestions, denunciations or congratulations. They are also used to locate you or your family and friends in the event of a natural disaster or emergency; this allows us to promote civic participation and the Ministry's rendering of accounts on its performance or to request you to evaluate your perceptions of the processes and services that the Ministry and its Revolving Fund provide.

You authorize the Ministry of Foreign Affairs and its Revolving Fund to handle the information you provide here, specifically for it to be used for purposes proper to their mission. These purposes are materialized in the performance of activities to provide their services, processes or products such as consular records, apostilles and legalizations, passport and visa issues, nationality, judicial cooperation, certifications, the authorization of public deeds, notarial acts, Colombia Nos Une and processes not provided for an exclusive to diplomatic personnel.

It is not allowed to wear hair or other accessories that cover the face. The image format is JPG and must have a maximum size of 300 KB. Do not use the photo of the previous visa

Be sure to attach a recent document-type photograph to the application that meets the technical requirements.

Applications with photos that do not meet the requirements would be unacceptable or rejected.

Avoid providing blurred, edited, cut, non-original photos or whose background lighting, and contrast do not allow the full identification of the applicant, or pretend to reflect or hide particular signs or an appearance that does not correspond to the real and current one.

Please upload the documents needed for your application as PDFs. Ensure all documents are clear and legible and upload using the upload icons indicated in the application.

1. Copy of the passport (only the identification data page), which must be valid for at least 6 months from time of the conference.

3. If you reside in a country other than your country of nationality, you must also provide a copy of the current official document proving such permanent residence.

4. The official invitation letter from Johns Hopkins University (ICFP2025) and our country co-hosts, which can be downloaded from Dryfta once you register for the ICFP 2025, can be utilized for this purpose, as it describes the nature and purpose of the applicant's visit to the country, and the duration and place of the activity.

5. If your travel is sponsored by an entity outside of your own funds, an additional letter will also need to be obtained by the organization supporting you and uploaded.

6. If the financial responsibility for the visa and travel is assumed by the applicant themselves, documents proving solvency (bank statements, labor certification) must be attached to the application.

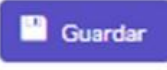

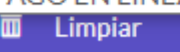
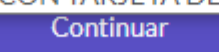

The application will be reviewed by the office, and you will receive an email notifying you of the outcome of the application review. The application fee has already been paid.

Consulates have up to 30 days to complete the visa application study and give a decision on the visa application. All consulates operate autonomously and may request further information from the applicant or require additional documents beyond the basic requirements and visa applicants are obligated to comply with such requirements. Failure to do so may result in the visa application being deemed inadmissible.

Your visa application does not mean automatic authorization. The application may be authorized, inadmissible, or rejected. Please comply with any additional instructions given by your consulate.

Remember that the visa application has **two payments**: the first one corresponds to the visa application/study fee when you are filing your application, and the **second one is only paid when your visa is authorized and corresponds to the issuance fee.**
